# Ousmane BADIANE – Executive Chairperson & Acting Managing Director, AKADEMIYA 2063 and Member of Mamo Panel



Dr. Ousmane Badiane, Distinguished Fellow of the African Association of Agricultural Economists, recipient of the Africa Food Prize in 2015 and member of the World Academy of Sciences, is the founder and Executive Chairperson of AKADEMIYA2063. He has over 30 years of experience, as academic and a practitioner, in international development. As the Director for Africa at the International Food Policy Research Institute, he was instrumental in developing and guiding the implementation of the Comprehensive Africa Agriculture Development Programme.

As Lead Specialist for Food and Agricultural Policy at the World Bank, he served as advisor to the Vice President for Africa and originated projects with funding ranging from US\$5 million to US\$150 million. Between research and development finance, Dr. Badiane taught Economics of Development in Africa at Johns Hopkins University's School of Advanced International Studies for many years.

Dr. Badiane received PhD in agricultural economics from the University of Kiel in Germany. He is also recipient of a Doctorate Honoris Causa from the University of KwaZulu Natal.

#### Fatma BEN REJEB - CEO, Panafrican Farmers Organisation (PAFO)

Fatma Ben Rejeb has been working with farmers organisations for more than 20 years. She began her involvement in land and legal affairs with farmers and their grassroots organizations. #### Isolina BOTO - Head of Networks and Alliances, COLEACP





Since its formation 10 years ago he has strategically led the organization in to resiliently build a sustainable food system focused on all-inclusive Agriculture, food loss mitigation and innovative food processing of Kenyan tropical fruits into natural and healthy fruit snacks. He is a graduate of Moi University School of Business and Economics, Eldoret, Kenya and holds a MBA Degree from USIU



Africa Nairobi. Alex also holds a postgraduate certificate in Business Development with Innovations from Frankfurt School of Finance in Germany. Alex envisions a world where African Agriculture will be able to feed the world while creating dignified employment

### Elizabeth NSIMADALA - President, Panafrican Farmers Organisation (PAFO)



Elizabeth Nsimadala is a Ugandan young agriprenuer, the President of the Pan Africa Farmers Organization (PAFO) and the Eastern Africa Farmers Federation (EAFF). She was recently appointed on the Advisory committee for the UN Food Systems Summit 2021, serves on the Global steering committee for Forest Farm Facility (FFF), is a Governing Council member for Africa Fertilizer Financing Mechanism (AFFM) and sits on the steering committee of Pan Africa Agribusiness Apex Chamber (PAAAC) among others. She is a passionate cooperator who with others

spearheaded the push to have the regional law on cooperatives - The East Africa Cooperative Societies Bill 2015 through the East Africa Legislative Assembly which awaits ascent by the EAC Heads of states. Elizabeth is also a farmer champion who has been at the fore front of championing farmer led agriculture technology and innovation through the EAFF farmers' owned eGranary mobile initiative that virtually aggregates farmers for input, service and output markets. As a result of her efforts in supporting Farmers Organizations, she was Globally recognized by the World Farmers Organization as one of the women contributing to sustainable development.

# Wim OLTHOF - Deputy Head, Rural Development, Food Security, Nutrition, European Commission

Willem (Wim) Olthof is Deputy Head of the Unit 'Rural Development, Food Security and Nutrition' of the Directorate-General for International Cooperation and Development of the European Commission. This unit deals with policy development and implementation of international cooperation related to food security, nutrition and sustainable agriculture.



From 2014 to 2018, he was the Alternate Permanent Representative at the Delegation of the European Union in Rome dealing with FAO, IFAD and WFP. Before that, he worked in Brussels and held posts covering policy development on agriculture, food security and nutrition, as well as on geographic cooperation with the Horn of Africa, specifically Ethiopia. During this period he was closely involved in the development of the external EU food security policy, in the EU resilience initiative for the Horn of Africa, as well as in establishing the € 1 billion EU Food Facility. In the period 1996-2005, he was posted in the EU Delegations in Sierra Leone, Ethiopia and Ghana.

Before joining the European Commission, Mr Olthof has lectured at the Institute of Social Studies in The Hague, The Netherlands, and at the Universities of Zimbabwe (1989-1992) and Addis Ababa (1996-1997) on rural and regional development.

#### Alice RIOUALL - Founder and CEO, Mango So, Burkina Faso

With a secondary education, Alice received and benefited from several training courses from different Associations which promoted and developed women in the informal sector in Ouagadougou (Burkina Faso).

In 2000, she decided to relocate her small business to the heart of mango production and orchards to better control the availability and supply of fruit.



It employed 15 people, mostly women.

In 2009 she became the president of the GIE CDS (circles des syers) specializing in the sale and promotion of organic dried fruits and vegetables from Burkina Faso and sold in Europe.

She then participated in various European fairs to represent the production of C.D.S. This allowed him to acquire good business knowledge. In 2016 MANGO-SO becomes a SARL company and itself exports its production to Europe.

Alice improves production quality by training all her staff in HACCP practices. She was distinguished as the best exporters of dried mangoes in 2015 by the APEX agency (Agency for the Promotion of Exporters of Burkina Faso)

In 2020 MANGO-SO SARL employs around 500 people, mainly young people and women. MANGO-SO diversifies its production by processing the coconut, which gives work to its staff all year round because the mango is a seasonal fruit whose production period lasts only 4 months. It is still thinking of diversifying its production panel by investing in the years to come by processing cashew nuts.

## Emanuele SANTI - Fund Manager at Bamboo Capital Partners, Luxembourg



Prior to joining Bamboo Capital Partners, Emanuele has worked for 15 years at World Bank and African Development Bank, where he has pioneered new program and instruments to support entrepreneurship and innovation, such as Souk Attanmia, the largest mobilization of partners to support social entrepreneurship in Tunisia in the aftermath of the Arab Spring, and Boost Africa, a blended finance vehicle enabling the market emergence of innovative forms of financing in the continent.

He also founded Afrilanthropy a platform connecting African social enterprises with wide variety of venture philanthropists, foundations and impact funds.

He holds a PHD in Development Studies from University of Trieste, MA in Economics from College of Europe in Bruges and a Harvard certificate on Public Financial Management.
