Philippe BINARD - General Delegate, FRESHFEL

Philippe Binard joined the fresh fruit and vegetables business in 1987. Since 2002, he is the General



Delegate of Freshfel Europe, the European Association representing the interest of the fresh fruit and vegetables sector. Freshfel incorporates more than 200 members (associations and companies) across the fresh produce supply chain from production down to retail.

Philippe Binard is also since 2001 the Secretary General of WAPA (World Apple and Pear Association) which gathers 18 leading apple and pear production countries around the world from both the Northern and Southern

Hemisphere. He is also Secretary General of SHAFFE (Southern Hemisphere Association of Fresh Fruit Exporters) incorporating the eight leading Southern Hemisphere countries exporting fresh fruit to world markets.

Isolina BOTO - Head of Networks and Alliances, COLEACP

Isolina is the Head of Networks and Alliances at COLEACP, a non-profit association of private sector



operators in the agrifood sector active in the European Union (EU), Africa, the Caribbean and the Pacific (ACP) regions. Isolina has more than 25 years of experience in agricultural development. She started her career with the European Commission, worked with various ACP embassies and NGOs in areas related to food security, rural development and trade. Before joining COLEACP, she was the Manager of the Technical Centre for Agricultural and Rural Cooperation ACP-EU (CTA) Brussels Office (2004-2020) implementing policy initiatives related to the ACP-EU cooperation in the field of agricultural and rural development. She has led trade and agribusiness projects in support

of capacity development of small and medium-sized enterprises (SMEs), entrepreneurs and farmers organisations across Africa, the Caribbean and the Pacific.

Dr Hubertus Gay read agricultural economics in Germany at the Universities of Hohenheim and Kiel,



but also studied in Newcastle-upon-Tyne, UK; Wageningen, the Netherlands and Pietermaritzburg at the University of KwaZulu-Natal, South Africa where he gained his PhD.

Dr Gay is a farmer's son from north Germany. In fact, his brother is now in charge of the family farm.

Dr Gay's professional career started with the oilcrops and feed analyst and forecaster Oil World (Ista Mielke GmbH). Then came a spell with the Thünen Institute in Germany in its department for agricultural and environmental

policies. He started to work for the European Commission in 2005, first in its Joint Research Centre (JRC) in Seville, Spain, and then in the Commission's General Direction Agriculture and Rural Development (DG AGRI) in Brussels, Belgium, where among his subjects were agricultural market analysis and quality labels. Since 2014, Dr Gay is in the agriculture and trade department of the Organisation for Economic Cooperation and Development (OECD) in Paris, France; specialising in the coordination of the annual OECD-FAO Agricultural Outlook.

the sustainability of LECOFRUIT's activities.








Frédéric ROSSENEU - Corporate Business Development Manager, Greenyard
