Christophe Aubé is a leading expert in technological innovation applied to agriculture and the



His areas of expertise include panel cointegration, pseudo-panels, quantile regression, generalised method of moments (GMM) and time series analysis.

Thomas Hildenbrand is the Director of the Fruit Department at SIPEF, a Belgium-based agro-



industrial company specializing in tropical agriculture. Trained as an agronomist with a master's degree in agricultural technology (horticulture), he began his career in Switzerland in 1983 before joining SIPEF in Côte d'Ivoire in 1984 as Production Manager and later General Manager at Plantations J. Eglin SA. Between 1990 and 1994, he founded and developed Société Bananière de Motobé, now part of Plantations J. Eglin SA, where he continues to serve as a director. In 1994, he moved to SIPEF's headquarters in Belgium as a

management representative and now leads the Fruits Department, playing a key role in the company's operations. With extensive experience in the fruit industry, he is also a member of the Board of Directors at COLEAD, where he contributes to the development of inclusive and sustainable agricultural practices.

#### Jeremy Knops – General Delegate, COLEAD

Jeremy Knops holds a master's degree in business engineering from the Solvay Brussels School of

#### Alice Riouall - CEO, Mango So, Burkina Faso

Fatmata Alice Riouall, founder and CEO of Mango-So SARL, has successfully transformed her small



street business into a prominent agro-processing company in Burkina Faso. In 2000, she relocated to Toussiana to ensure a steady supply of mangoes, and by 2009, she had expanded her expertise, becoming president of GIE CDS, specializing in organic dried fruits and vegetables. In 2016, Mango-So was officially registered as a limited liability company, employing over 300 people, 90% of whom are women, and exporting 90% of its dried mangoes and coconuts to Europe. Alice's commitment to quality is demonstrated through the implementation of HACCP standards and the acquisition of organic

certifications. Recognized by APEX in 2015 as the best dried mango exporter, she continues to innovate with new products like mango jam and syrup, and has plans to diversify further by processing cashew nuts. Beyond her entrepreneurial achievements, Alice is passionate about supporting education, gender equality, and community development, making a significant impact both in business and in her local community.
