#### Maryan Setrodikoro - Director, Eden Herbs and Spices, Suriname

Maryan Setrodikoro is the Director of Eden Herbs & Spices NV, a Surinamese company



specializing in medicinal herbal products. Under her leadership, the company has expanded its product line to include teas, powders, spices, capsules, and herbal remedies, which are selectively distributed to ensure proper customer guidance. In September 2024, Setrodikoro received eight new production machines through the Suriname Growth Enterprise (SURGE) programme, a World Bank-funded initiative aimed at enhancing the competitiveness of local businesses. This investment has enabled Eden Herbs & Spices to fully automate the production of its 18 products, leading to increased output and improved quality. Additionally, Setrodikoro has embraced digital commerce, utilizing

platforms like Take App to facilitate online orders and payments, thereby expanding the company's reach and customer engagement.
